# History in Paradise

Hosted by Norfolk Island Museum

A range of interesting speakers, covering topics such as stories from Norfolk Island's Second British Settlement, Female Immigration to Australia in the 1830s, and the use of DNA in genealogical research have been organised for concurrent sessions.

The program for the week includes special museum and cemetery tours within World Heritage listed Kingston and a great Island-style Congress dinner Fish Fry.

#### Keynote Speakers: Ray Martin

One of Australia's most respected television journalists and entertainment personalities, and also among the most awarded stars of Australian television, having won the coveted Gold Logie five times. Norfolk Island is honoured to have Ray Martin as official Brand Ambassador. Ray returned to the Island in 2016 with an open brief to experience its quirkiness and charm and maintains a particular fascination with the historical connection with Australia.

"Discovering Who I Am" – a lifetime spent in journalism has seen Ray Martin witness some of the defining moments of his time. Looking into his own history he finds his forbears too were on the frontline of nation shaping events – discovering an ancestor at the scene of Australia's greatest armed rebellion. On his maternal side he walks in the footprints of his indigenous ancestors to solve a long-standing family mystery. And he follows his convict trail back to Ireland to find a notorious bandit with a rebel heart.

#### Keynote Speakers: Babette Smith

An independent historian who holds an adjunct position with the University of New England. In 2015 she was awarded an Order of Australia Medal (OAM) for her services to Australian history.

"Family History" – its significance in Australian historiography, its importance in current debates and future challenges. The uncovering of convict society that began in the eighties made a significant contribution to Australian historiography, yet today this story risks being lost. Recognising both its intrinsic significance, but also its potential importance in negotiating full reconciliation with Indigenous people, family history societies must ensure this does not happen. Babette will argue that this dilemma is not confined to Tasmania and Australian family history societies need to be at the forefront of debate.

"RESISTANCE" – covert, subversive, but alive and kicking, resistance was a feature of all the penal colonies including the secondary punishment settlements. Examples about male and female convicts will illustrate the variety and form it took. Prisoners individually made their point in many ways, often at risk to themselves. When they acted collectively, however, they turned 'resistance' into power. Have we underestimated just how powerful the convicts were? What might be the implications for interpretation of Australian history in the longer term?

#### About Norfolk Island

Norfolk Island's story is really quite incredible with Polynesian migration 'book-ending' four distinct settlements of people. As the most westerly point of Polynesian migration, human habitation began 750 years ago with Polynesian contact.

Following two British penal settlements (1788-1814 and 1825-1855), the descendants of the Polynesian women and Mutiny on the Bounty men arrived in 1856 from Pitcairn Island, and their rich cultural legacy shapes the Island today.

The Island's history, heritage and culture are equally matched with a stunning pristine environment and unique bio-diversity. These can be seen within the rainforests in the National Parks; an unspoilt marine reserve of reef that fringes the World Heritage Site in Kingston; and at the Island's beaches.



### Northamptonshire Hearth Tax Index 1673-74

Members of your affiliated societies may be interested to hear that I have recently launched a fresh index of the 1673-74 hearth tax lists for Northamptonshire, England along with a detailed introduction. There are over 22,000 records, providing names and other details of the vast majority of householders in the county sorted by name, by parish/town and in their original order. It is the most complete snapshot of local residents earlier than the 1841 census.

# How QFHS survived during COVID-19

Our QFHS library is open again after the Easter COVID lockdown. The Management Committee is encouraging members to come into the library to read, research and meet old friends.

Back in March 2020 when COVID 19 first appeared we had to introduce access restrictions. In the intervening period our members have become well versed in searching our on-line resources both our QFHS records and datasets and our QFHS library subscription sites.

Our financial year ends 31 March. And during this COVID year we have been able to report that membership has grown by 4% and our financial position has improved with a modest surplus.

As the management committee we would like to claim this success. But with all volunteer societies, it is the hard work done previously that has held us in good stead.

The society produced a Strategic Plan which identified some key areas to retain members and add benefit to the society. These included:

1 Remote Access - Building more capacity for members to do on-line research.

2 Encouraging more 'regional members' to join.

In 2019 the society loaded a considerable number of datasets and searchable collections. And in 2020 we accelerated this to load over 12 million data lines.

This together with addition subscription site available on our website, allowed members to keep busy with their research and safe at home.

The percentage of 'regional' members has steadily increased. We are nearing 40% of our members live outside the greater Brisbane area. This is pleasing as it builds a larger and broader membership base.

Another factor has been the uptake in members using Zoom. Since the COVID lockdown all our SIG (Special Interest Groups), education and new member orientation meetings have been via Zoom. Again, we have seen more regional members joining these groups and conversations.

As I said earlier, we know need to work on a solution to reactivate the library and continue to provide equity to all members.



### NZSG Kiwi Collection Online: a new generation of Kiwi

The NZ Society of Genealogists (NZSG) has just launched a new online edition of its flagship product, the Kiwi Collection - a powerful online research tool for members researching their New Zealand family history.

#### What is Kiwi Collection?

Kiwi is a database of indexed record sets and transcriptions representing the work of hundreds of NZSG members over the past two decades, either as individuals or through NZSG projects. Available only to individual NZSG members, the purchase cost associated with Kiwi not only supports that ongoing effort, but also helps fund the Society's other work.



The new online version is the gateway to a vast, meticulously compiled index of over 11m records across 312 record sets, allowing users to locate the records they need and find exactly where and how to access them.

Record sets indexed currently include everything from Gazette notices, cemetery records, shipping passengers and hotel licenses to rolls of honour, land applicants, probates ... and the intriguingly named Pandora's Box (an index of over 380,000 records from official Government publications and a miscellany of regional histories, schools lists and periodicals). Another new addition is the national index for Notices of Intention to Marry.

Kiwi also includes indices for the NZSG's exclusive record collections: Pedigree Registrations; Pre-1856 New Zealand Marriages; NZSG Certificates; NZSG First Families; and NZSG Obituaries, as well as indexes to The New Zealand Genealogist from 2016. Information from these NZSG Record Collections is available to NZSG members only, for their personal research, and is a major benefit of NZSG membership.

While most records indexed require you to contact an NZSG Officer, Branch or other holder of the record set to get the full record details, you can deduce a lot from the indexed information – and in some cases you might not even need to look at the full record to satisfy your curiosity! Of course, viewing the original record can often provide broader context or add information that is otherwise unexpected. Most importantly, Kiwi helps you compile your research to-do list before you go any further – saving you a lot of time and helping you 'connect the dots' across resources.

# Branding for HAGSOC and Family History ACT



As you are aware there has been a change to how HAGSOC has been representing itself recently. Many will be aware that our website address is 'familyhistoryact.org.au', and that on the website we refer to ourselves as both 'Family History ACT' and 'The Heraldry & Genealogy Society of Canberra Inc.'. Indeed, we have been using these terms interchangeably which has caused some confusion.

To dispel some myths and clear up any misunderstanding, HAGSOC has not 'changed its name' to Family History ACT. And we are not 'formerly known as' HAGSOC. Let me explain ...

'The Heraldry & Genealogy Society of Canberra Inc.' is still our registered legal name. (ABN 50 317 924 321) This title is to be used in all legal and financial documentation.

'Family History ACT' is a registered 'Business Name' for HAGSOC that we have been using for the last few years. This is not a 'Trading as' name: Rather it is our business name which can be used for advertising, general reference or where a formal (legal) name is not necessarily required.

In recent years a number of family history organisations have changed their names. For example, The Western Australian Genealogical Society Inc now uses the operating name *Family History WA* and the Australian Institute of Genealogical Studies now refers to itself as *Family History Connections*. The fact that other organisations are changing their names is not a reason, in itself, for us to change. But it is a reflection of the challenges facing all family history groups to keep pace with changes in the way family history is undertaken in an increasingly technological age, to attract new members and to remain relevant to the next generation of family historians.

In an effort to modernise our name, to make it more electronically searchable and to appeal to a younger cohort of future members, Council has decided to adopt the title of 'Family History ACT' for general use.

'The Heraldry & Genealogy Society of Canberra Inc.' will remain our legal name, but we will now refer to ourself as **Family History ACT** or **FHACT**. Our logo will not change, but our branding will be altered to reflect our new naming convention and will soon begin to appear on our new website and in publications and marketing materials. # The Harry Gentle Visiting Fellowships at Griffith University

#### About Harry Gentle and the Fellowships

Harry Gentle was a Griffith University alumnus who studied politics and history in the 1980s in the Griffith School of Humanities. He left a generous bequest upon his death to support the ongoing study of Australian history to the 1850s. With that support the Harry Gentle Resource Centre at Griffith University is developing a portal of research dedicated to the study of the peoples and lands of Australia, with an initial focus on the area that became Queensland and its borderlands in the nineteenth century. We encourage creative approaches to documenting, representing and interpreting that history.



Centre for Social and Cultural Research

Our aim is to offer an online portal of interactive resources, research publications, commentaries and research aids to facilitate access to published and unpublished information for this period, an era of important intercultural encounters. We seek to document particularly the lives and experiences of those persons, groups and organisations that have not been the subject of historical investigation. We acknowledge the diverse people, groups and claims on country that made up the early colonial period, including Indigenous diplomats, resisters, interpreters and guides, convicts and free-born, shipwreck survivors and settlers, religious and military – the whole range of contributors to a new era.

We invite applications from innovative scholars in a discipline relevant to digital history or the creative arts to join us for a period as Visiting Fellow, and contribute to the aims of the Harry Gentle Resource Centre. The outcome of your research on resources related to the early settlement of Queensland may be presented via creative works such as photographic or art exhibitions, short stories or historical documentaries as well as through conventional publication.

#### Fellowship specifications

Three Fellowships are available for commencement in August 2021. We offer shared office space, staff access to Griffith University resources and the growing digital resources of the Harry Gentle Resource Centre. An honorarium of \$7,500 is attached to each Visiting Fellowship. The duration of the Fellowship is flexible up to a period of one year.

The Harry Gentle Resource Centre is located within the Griffith Centre for Social and Cultural Research, and Visiting Fellows will have the opportunity to engage in the Centre's research events and culture. A Visiting Fellow will be asked to present a public lecture towards the end of their tenure and to contribute to our publication output in print and digital forms. We also expect Visiting Fellows to submit an interim report on their progress and a final report on outcomes at the conclusion of the fellowship.

#### How to apply

Please send us a proposal outlining the project you intend to complete during the Fellowship. Applications should be submitted by 11 June 2021, with a commencement date of 1 August 2021. For information including consultation about suitable approaches and methods please contact the Director of the Harry Gentle Resource Centre Professor Mark Finnane via email at <u>m.finnane@griffith.edu.au</u>.

The Fellowship application should include:

- Personal details of the applicant (name, contact details, etc.)
- A biographical note and short CV (2 pages)
- Title of the project and abstract (up to 100 words)
- Key words (up to 5 words)
- Detailed description of the project (up to 500 words)
- Proposed project timeline (up to 200 words)
- Research outcomes and results (up to 200 words)
- Attach a key research output, or an excerpt of at least 1000 words
- Indication of research progression -- has this project commenced? Have you applied to other funding bodies?
- Referees (2).
