## PROBATE CALENDARS FOR ENGLISH AND WELSH WILLS

*Ancestry* has released probate calendars for English and Welsh wills between 1861 and 1941, but with some gaps.

This collection contains summaries of the vast majority of probate cases in England and Wales between 1861 and 1941. It effectively forms an index to wills and probate records for this period.

The records were created by the Probate Registry, which took control of proving wills and administrations in 1858. Before this, four different types of ecclesiastical courts dealt with these cases. A Principal Probate Registry was established in London in January 1858, and several district probate registries were created around the country. From then on, the registries oversaw all grants of probate and letters of administration. This collection is the Calendar of these grants.

The Calendar is separated into a different volume for each year. The entries in each volume are then alphabetised by surname. Information varies across different entries, but each typically includes:

- \* Probate date
- \* Full name of the deceased
- \* Death date
- \* Death place
- \* Registry where issued

Missing volumes:

The collection covers 80 years from 1861 to 1941. *Ancestry* currently do not have the books for the years 1858–1860 and there are some gaps for the years 1863, 1868, 1873, 1876, 1877, 1883, 1888, 1899–1903 and 1910–1911. However, they hope to add records for these years as soon as possible.

#### **NEW PUBLICATIONS**

#### NZ COMBINED ELECTORAL ROLLS 1881, 1893, 1896

1881 Electoral Rolls contain over 120,000 records; 1893 contains over 300,000 records and 1896 contains over 330,000 records. By combining these rolls into one database researchers are able to see family connections, by electoral district with the addition of woman and children over the age of 21 from 1893; look at the geographical movement of family members, compare the choice of the women in your family as to whether the hype of the 1893 election (about the ability to vote in a general election) carried over to the 1896 election.

This also includes copies of the electoral maps of the times, published compliments of Alan McRobie, from his NZ Electoral Atlas

#### A RETURN OF FREEHOLDERS OF NZ OCT 1882

This is a searchable PDF which gives the names, addresses and occupations of owners of land throughout New Zealand at that time. It includes the area and value in counties and the value in boroughs and town districts.

Note: Maori land ownership is omitted in the original records.

Compiled by the NZ Property Tax Department from Assessment Rolls, these records were published by the Government in 1884.

# THE JIM PEARCE INDEX OBITUARIES REPORTED IN THE EVENING POST 1929–1977

National Family History Week

It's all about you

This collection was assembled between 1927 and 1977 by librarians working for the *Evening Post* in Wellington New Zealand. Following the merger of the *Evening Post* and the *Dominion* newspapers in 2002 the collection was gifted to the Wellington City Libraries by *Fairfax (NZ) Ltd.* The Kilbirnie Branch of the New Zealand Society of Genealogists Inc indexed this collection over a long period on a voluntary basis to produce this index. The Index is

## PATIENTS IN MELBOURNE HOSPITAL 1856-1905

An index of 49,552 names from medical records, hyperlinked to a set of details extracted from the patients' medical record, these records were extracted by volunteers from the Genealogical Society of Victoria from the War Books of the (Royal) Melbourne Hospital. An estimated 2,000 Ward Books are extant but many more have disappeared. There are 451 Ward Books which have been indexed to this CD. The original records are held at the Public Records Office Victoria. Not all the extant books in the period to 1905 have been indexed yet.

These details contain the patient's name, age, and admission date together with some or all of the following: the patient's biography; birth place; the ship on which the person travelled to Australia and its arrival date; whether married, widowed or single; occupation; religion; residence and the result of treatment. Each set of details includes the full reference to the relevant Ward Book's location at PROV. A patient's disease or complaint can only be ascertained by viewing the Book at PROV, or by using the GSV's Research Service.

## BRUNY ISLAND: CEMETERIES OF SOUTHERN TASMANIA, VOL. X

This CD covers the cemeteries of Adventure Bay, St Peters—Barnes Bay, Alonnah, Lunawanna, Shetler Cove and some Miscellaneous Memorials.

Each Bruny Island Cemetery has a brief history/ description, plan, details of how to get there, and a list of the individuals identified in the cemetery. Where available each individual has a photograph of the grave and/or headstone, a transcript of any wording, and a plot number. Many inscriptions were recorded up to thirty years ago so that, in some cases, a transcription is given even though it may no longer be clear on the tombstone. All iden-*Newsflash Issue 37*

### ASK GRANNY®

Ask Granny<sup>©</sup> is an innovative genealogical outreach program especially designed to be presented by local genealogical society members at assistedliving or retirement homes or other places where seniors gather, such as a Community Council on Aging. The program can also be used as a workshop event at a family reunion or at a church or synagogue senior group. Funded entirely by small local contributions, the authors provide free specially formatted materials and instructions via emailed pdf files. Genealogical society members can easily use the materials to guide the seniors as they create a simple ancestral chart for themselves and for their spouses. There are also Ask Granny administrative helps, such as flyers, announcements, and teaching outlines. The pdf files can be easily printed for students or made into slides, flyers, or posters.

The program is very different than a beginning genealogy course. Using only pencils and paper, the grannies and grandpas who attend the seminars record their memories of family names, dates, and places on a chart labelled, A Genealogical Gift to my Family. When those pages are preserved in their special gift folder, family members will never have to wonder why didn't we ask Granny about that? Whether the students can remember the details of one generation or six, they create an irreplaceable record of family history for their grandchildren and great grandchildren. At every session, even seniors who think they will remember nothing have been able to record several generations with the help of their instructors. One retiree from Poland said, Thank you! I always wanted to create a family tree, but I never knew how.

Since 2009 the authors of *Ask Granny*, Judy Russell and Greg Crane, have presented the program many times in retirement centres and for local senior groups, such as Community Councils on Aging. They also report that it has also been adopted by genealogical societies, family reunions, and schools in Australia, Canada, the United Kingdom, and in thirty states in the USA.

Write to the *Ask Granny* authors with your questions or your request for a free set of materials by return email. Your email should include the name of your genealogical society or the name and date of your upcoming family reunion or church/syna-

gogue group. The only stipulation of the authors is that students are never charged for their participation in an *Ask Granny* seminar or for the materials.

#### **OLD HANDWRITING 1**

You may be faced with a number of challenges...

- Abbreviations come in three basic forms:
  - abbreviations—words with endings left off.
  - contractions—letters within omitted.
  - ligatures—grouping of common letters to form an entirely new letter.
- Latin, or an ecclesiastical version of it, may be the written language.
- The spelling may be based on phonics and may not be consistent.
- Numbers could be written in Roman Numerals.
- Months may be partly written in numerals as in VIIIber for October and not August because it is abbreviating the Octo part of the word and October was the eighth month by the Julian calendar.
- Punctuation will not be precise and often omitted altogether. If it was there, it was often used as a decoration. A virgule [/] may be used as a full stop. A hyphen when used was like an equal sign. Quotation marks were never used. The possessive apostrophe was rarely used. A heavy version of a full stop called a punctus may be observed but this is not a punctuation mark but rather a symbol of abbreviation.
- Various marks known as line-fillers will often be seen at the end of a line to fill up blank space especially in legal documents.
- Capital letters were often used mid-sentence to emphasise a word.
- Some unfamiliar or old fashioned words and expressions may be used—consider: terriar, glebe, cromulent, faitor, meagry, individuum, noggin.

There are some issues you will face that will not help the situation. Consider all the following possibilities being added into the mix:

- ink may have faded or even dropped off the page.
- pages may be stained with mould.
- the writer may have failed to keep their quill sharp or crossed their nib resulting in a thick blotchy text.
- the filming/photocopying process used to provide you with the copy may be inferior.
