Patron sign in will also enable FamilySearch to satisfy the ongoing need for user authentication. This authentication can deliver rich, personalized discovery, collaboration, and help experiences. Simply put, signed-in visitors can access more searchable content and enjoy more personalized services.

"A large percentage of our current site visitors are not benefiting from much of what FamilySearch has to offer because they don't realize the need to simply sign in with their free account to do so," said Steve Rockwood, FamilySearch CEO. "They are basically arriving in the parking lot but not coming inside for the main event," he said about website visitors who do not sign in.

### Joan Reese Memorial Short Story Competition 2018 New Cash Prize

### "My ancestor was a ...."

The 2018 Joan Reese Writing Competition will for the first time have a cash prize to the value of \$100. The Joan Reese Memorial Short Story Competition recognizes the contribution of Joan Reese in the significant provision of access to NSW Colonial records and her support to GSQ and its members over many years. The winning stories appear in subsequent issues of the Society's quarterly journal, Generation, and are published on the Society's website at www.gsq.org.au.

The topic for 2018 is "**My ancestor was a** …" and provides a wide scope for stories about ancestors that may shed light on, for example, their occupation or calling; religion; nationality or origin. Your ancestor may have been a pioneer or explorer, a sporting hero or a decorated member of the armed forces. You may choose to write about a female ancestor or a male member of your family.

In 2018, stories will be judged on the following criteria:

Content:

- addresses the topic set for the year
- provides the reason/s for your choice of topic
- includes evidence of your research

Presentation:

- uses standard English sentence construction and variety of expression
- is readable
- uses consistent form of references or citation of sources
- contains appropriate illustrations, with captions if used

Overall impression:

- is an interesting story
- is a well presented.

Judging panel:

- President of GSQ, or nominee
- Convenor of the GSQ Writing Group
- Independent judge.

#### Eligibility

- Members of GSQ are eligible to enter for no cost
- Non-GSQ members can enter upon payment of an entry fee of \$10
- Editor of Generation, Convenor of the GSQ Writing Group and members of the Judging Panel are not eligible.

#### Length

• Maximum length to be 2500 words.

#### **Conditions of entry**

- The story must not have been previously published
- Multiple stories can be entered (with non-members paying an entry fee for each entry)
- Endnotes/references will not be included in the total word count
- Entrants are encouraged to include a photo of relevance to the story. Approval must be sought, where appropriate, for permission to use any photographic or other material which is subject to copyright
- Entries must be in Word or Word Compatible format, font to be Times New Roman 12 or Arial 12 with double line spacing.

#### **Deadline for submissions**

- Entries must be received no later than 10 May 2018 (no entries will be accepted after that date).
- Entries to be emailed to <u>info@gsq.org.au</u> with "Joan Reese Writing Competition" in the subject line.

# **Australian Century Farm and Station Awards**

# The ACFSA celebrates our national agricultural heritage by capturing and preserving rural history which might otherwise be lost.

Families who have owned and operated their properties for more than 100 years understandably have great pride in what they have accomplished. It is a heritage forged of courage and determination, and often a pinch of luck!

In "a land of droughts and flooding rains", keeping the farm or station from generation to generation is an impressive achievement.

The ACFSA through an annual awards program aims to keep these stories alive and celebrate this heritage.

Agriculturalists are faced with the ever growing challenge of feeding, clothing and sheltering a nation that has become increasingly distant from the source.

As the distance from producer to consumer increases, so lessens the understanding of all that we do and that our forebears have done to shape this nation.



#### The Awards

An invitation is extended to all Australian families farming their land for 100 years or more to apply for a Century Farm or Station award, or the Sesquicentennial award. (150 years)

All types of primary production including viticulture, horticulture and forestry are eligible. The awards are not tied to a specific amount of land although some of the original selection must remain in family ownership.

Applicant families must submit verification of this, generally copies of deeds etc. They are also required to write a narrative of family history and if possible enclose photographs both historic and modern to illustrate that story.

An agreement to archive the collected material has recently been forged with the prestigious Noel Butlin Archives, Australian National University, Canberra, A.C.T

Copies of the archived material will also be housed at the national ACFSA centre in Collector, when a suitable building is acquired.

The awards are ongoing and open each year on January 1st, closing on December 31st.

The 2014 awards will be presented in Canberra at a gala celebration in early 2015.

Each applicant family will receive a handsome bronze plaque commemorating this milestone. The plaque can be placed at the property gate or hung on a building.

Wherever you may choose to display it, the plaque will symbolize your family's perseverance and their ability to keep farming or grazing in the face of constant change.

Above all else, it will represent the hard work and desire to continue what was 100 years ago a dream, then a reality, and now a family tradition.

# **Nick Vine Hall Award**



Nick Vine-Hall AM

The Nick Vine Hall Award is awarded annually to member societies (in two categories based on membership) for the best family history journal/newsletter in Australia and New Zealand.

AFFHO provides this award to encourage its member societies to produce quality journals/newsletters, and to honour Nick Vine Hall AM.

The late Nick Vine Hall fervently supported and represented AFFHO at a National level in a *Save the Census Campaign* in the mid 1980's. Nick utilised his personable skills as a researcher, author, radio presenter and speaking engagements towards the final achievement that was announced by the Federal Government of their acceptance of the Standing Committee on Legal and Constitutional Affairs report *Saving our Census and Preserving Our History*.

This permitted citizens across Australia to "opt in" and allow retention of their 2001 and future Census information, under

closed access for 99 years, by the National Archives of Australia, and in so doing, made a valuable contribution to preserving Australia's history for future generations.

#### Categories

The Nick Vine Hall Award is made annually in two categories:

- Category A for societies with less than 500 members
- Category B for societies with 500 or more members

#### Prizes

- First prize Wall plaque and \$300 to the Society; Certificate to the Editor
- Second prize Certificate and \$100 to the Society; Certificate to the Editor
